This is an open-ended agreement. If the business wishes to change or terminate this agreement, it must notify the GTCBMS by email or phone, and allow time for us to inform the membership of the changes or termination.

In consideration of the participation by the undersigned business, the GTCBMS agrees to provide the following:

- A certificate identifying the business as participating in the GTCBMS Discount Program.
- A listing on **www.gtcbms.org** of your business, website and email address that you authorize and provide below to be used on the GTCBMS Member Discount List
- A list of participating businesses will be displayed at GTCBMS sponsored events.

The GTCBMS Member Discount List will be updated as needed to add, change and/or delete businesses and benefits/discounts. The GTCBMS Member Discount List may be printed from the web site **www.gtcbms.org** at any time.
